Fully paid up overseas associate members receive newsletters, mailings and the GTA trade handbook. They are entitled to be present at general meetings of the Association but they do not have the right to speak or vote at such meetings, nor may they be counted in a quorum at a general meeting of members of the Association, or demand a poll, or be entitled to require a meeting to be held. Overseas associate members are not eligible to be elected as members of the GTA Council or to be elected as Honorary Members.
